



## CONFIRMATION OF THE NON-ACQUISITION OF BRITISH CITIZENSHIP

If you are a foreign or Commonwealth resident in the United Kingdom, and require confirmation for the authorities of your home country that you have not become a British citizen, you should apply for confirmation using this form. Submit both parts of this form together with the payment slip from the fees leaflet.

You should allow 10 working days for confirmation. Payment should be made by debit or credit card or postal order ONLY. There will be no refund of fees. Payment by cheque will delay a reply.

Your personal details should be correctly stated on BOTH parts of the form. Part 1 will be retained as a record of the search of UK Border Agency records. Part 2 will be forwarded to the address given. The UKBA does not retain records of the grant of citizenship prior to October 1986.
